Adam Dalrymple, President, British Crown Counsel Association, Canada

Adam has been a prosecutor for approximately 17 years and is the President of the British Columbia Crown Counsel Association as well as the Vice-President of the Canadian Association of Crown Counsel. As a director and member of the executive of these Associations he has focused on mental health and wellness for prosecutors, good governance, access to justice, and prosecutorial independence. He is a strong proponent of prosecution exchange programs. In 2017, he spearheaded the first mental health survey of prosecutors in British Columbia and Canada. His prosecution practice is varied. He is currently assigned to Vancouver Youth Court and a largely Indigenous circuit court on British Columbia's Central Coast. When he's not working, he enjoys to travel, workout, hike, softball, and walk his 4 year old Chocolate Labrador Retriever, Bourbon, on the many trails in and around Vancouver.

Sally Dowling SC, Director of Public Prosecutions, New South Wales, Australia

Sally Dowling SC was appointed as Director of Public Prosecutions (NSW) in August 2021 for a 10-year term.

Ms Dowling graduated from the University of Sydney in 1994 and was admitted as a solicitor in 1995. Called to the Bar in 1997, she worked in private practice until 2002 when she was appointed a Crown Prosecutor and joined the ODPP. In her 16 years in the Office, Ms Dowling prosecuted hundreds of matters, at trial and on appeal. She was appointed Senior Counsel in 2013 and in 2016 was appointed a Deputy Senior Crown Prosecutor and head of the Appeals Unit.

In 2017, Ms Dowling was appointed to the Racing Appeals Tribunal NSW, and in 2019 acted as Senior Counsel assisting the NSW Special Commission of Inquiry into Crystal Methamphetamine.

In 2020 Ms Dowling returned to the private Bar, appearing in coronial inquests and in criminal and regulatory matters both for the prosecution and defence.

Raelene Sharp KC, Director of Public Prosecutions, Commonwealth, Australia

Raelene Sharp KC was appointed the Director of Public Prosecutions (Cth) on 4 December 2023, for a 5-year term.

Ms Sharp has over 20 years' experience in both domestic and international legal domains, specialising in criminal law, investigative and administrative law. In addition to Bachelors in Law and Arts (majoring in linguistics), she has a Master of Laws in Public International Law (International Criminal Law) from Leiden University.

Before being called to the Victorian Bar in 2010, Ms Sharp worked as a solicitor for 10 years, first at the Office of Public Prosecutions (Vic), at the (then) Australian Crime Commission and at the United Nations in Lebanon.

Ms Sharp was appointed senior counsel in 2022.

Ms Sharp sits on the Criminal Justice Law Enforcement Forum, the Serious Financial Crime Taskforce and the Commonwealth Association of Directors.

Deputy General Prosecutor at the Cassation Court (France)

Belinda Hughes, Executive Director Legal, Independent Commission Against Corruption, Papua New Guinea

Belinda Hughes has a career history of over 19 years in law enforcement and regulation.

Beginning her career with the NSWPF she spent over 10 years prosecuting all levels of crime as a senior prosecutor. She spent 3 years leading the team and prosecuting outlaw motorcycle gangs and criminal groups in New South Wales. Her biggest prosecution was of 55 gang members. Belinda left NSWPF as a Sergeant and specialist legal advisor in counter terrorism and major incidents.

Belinda moved to Transport for NSW as a Senior Manager leading 30 prosecutors, administration staff and managing over 36,000 matters per year.

Following there Belinda moved to the National Heavy Vehicle Regulator as the National Director of Prosecutions. Leading a team of 50 based across five states and a territory.

Belinda is now the Executive Director of Legal for the Independent Commission Against Corruption in Papua New Guinea.

Belinda has a Diploma in Policing, a Bachelor in Criminology, a Bachelor of Laws and a Masters in Law (Criminal Practice).

Nchimunya Munkombwe, Senior State Advocate, National Prosecution Authority, Zambia

Mr. Nchimunya Munkombwe is a Senior State Advocate under the National Prosecution Authority in Zambia. He was appointed Senior State Advocate and deputy provincial head in Eastern province on 22nd June, 2022. He has been involved in the criminal prosecution throughout his working career. He jointed the National Prosecuting Authority on 1st January 2018 as a State Advocate and before that he worked as a Senior Public Prosecutor under the Zambia Police Service from 2nd July, 2003. He holds a certificate in basic prosecution from the National Institute of Public Administrate. He also holds a Law degree and a Master's degree from the University of Zambia. He was admitted to the Zambian Bar on 24th March, 2017.

In 2019, he received an award from the Judiciary of Zambia in recognition of his contribution towards restoring dignity for the incarcerated.
